What is HIPAA?

The HIPAA Transaction and Privacy regulations require health care provider compliance in 2003. HIPAA was enacted in 1996 to give employees the ability to make their company health insurance portable. Over the years, it has evolved to include the following standards:

- Formats for the electronic transmission of patient information
- Processes for protecting the privacy of patient information
- Processes for ensuring the security of patient information

The laws are complex and difficult to understand. We estimate it can take a small to medium size practice between 500-1000 hours to develop, complete and implement a compliance plan on its own. HIPAANow! will help you reach compliance in less than 1/10th that time!




